

DISPLAY OF THE COURSE SIGNALS IN THE PORT OF NAGOYA

Vessel navigating in the port of Nagoya by day equipped with the International Code Flag, which intend to enter or leave the port, should indicate their destination by giving signal flags as shown in the chart below placed well visible such as on the mast.

However, no vessel is required to display by night and/or equipped free with signal flags.
